

Minutes of Special Meeting held on 25th November, 2010.

Cllr. A. Phelan welcomed Evelyn Graham Architect to the meeting. She is replacing Aine Doyle who is on maternity leave.

Denis Malone gave a presentation to the members on each of the items in the Managers Report. He outlined the process involved in making additions and deletions to the Record of Protected Structures. Each structure would be voted on individually.

Contributions were received from Cllr. M. O' Brien and M. Shortall in relation to the first four structures listed in the County Managers report.

1. ADD 28/10 – Cast Iron Post Box Corluddy, Carrigeen.

Proposed by Cllr. C. Long, Seconded by Cllr. P. Dunphy and agreed.

“That the Cast Iron Post Box at Corluddy, Carrigeen Ref ADD 28/10 would be added to the Record of Protected Structures”.

2. ADD 50/10 – Ringville House, Ringville.

Proposed by Cllr. P. Dunphy, Seconded by Cllr. P. O' Neill and agreed.

“That Ringville House, Ringville Ref ADD 50/10 would be added to the Record of Protected Structures”

3. ADD 55/10 Barrack Street, Castlecomer

Proposed by Cllr. P. O' Neill, Seconded by T. Maher and agreed. “That Barrack Street, Castlecomer Ref ADD 55/10 is not to be added to the Record of Protected Structures”.

4. ADD 65/10 Castlecomer House, Drumgoole

Proposed by Cllr. M. Shortall, Seconded by Cllr. J. Brennan and agreed “That Castlecomer House, Drumgoole Ref ADD 65/10 would be deferred to the next round of Record of Protected Structures additions for County Kilkenny.

Cllr. B. Manning advised the meeting that she was withdrawing at this stage as she has an interest in the next structure.

5. ADD 68/10 High Street, Inistioge.

D. Malone outlined to the members the reasons for adding this structure to the Record of Protected Structures and outlined the submissions received from 2 parties.

Contributions were received from Cllrs. M. Noonan, M. O' Brien, P. O' Neill, M. Shortall, T. Breathnach, P. Cuddihy, M. H. Cavanagh, P. Millea, S. Treacy and C.Long.

Members stated that the building only consisted of 1 ½ walls, was a safety hazard, did not contribute to the streetscape. Queries were raised in relation to building on the site. Retaining the wall as a boundary and reusing the stone.

D. Malone advised members that the deadline for making a decision was 3rd December, 2010. A house could be built detached from these existing walls.

It was proposed to add this structure to the Record of Protected Structures by Cllr. M. Noonan and seconded by Cllr. T. Breathnach.

An amendment not to add this structure to the record of protected structures was proposed by Cllr. P. O' Neill and Seconded by Cllr. S. Treacy.

A vote was taken on the amendment.

Members voting to add the structure were as follows:-
Cllrs. M. Shortall, M. Noonan and T. Breathnach. **Total 3**

Cllr. P. Crowley abstained.

The amendment was carried by 16 votes to 3.

“That High Street Inistioge Ref ADD 68/10 would not be added to the Record of Protected Structures”.

Proposed by Cllr. P. O' Neill, Seconded by Cllr. S. Treacy and agreed: “That Kilkenny County Council hereby approves of the proposed additions and deletions to the

Record of Protected Structures for County Kilkenny in accordance with the report forwarded to members on 9th November, 2010 and amended accordingly at the meeting on 25th November, 2010”.
