Cllr. Paul Cuddihy opened the Statutory Budget Meeting at 3.30pm.

It was proposed by Cllr. M.H Cavanagh, Seconded by Cllr. T. Maher and agreed that the Statutory Budget Meeting for 2012 be adjourned until 4pm to allow the members to have a discussion in Committee.

The Statutory Budget Meeting resumed at 4pm.

It was proposed by M.H Cavanagh, Seconded by Cllr. T. Maher that the Statutory Budget Meeting be further adjourned until 4.25pm.

Statutory Budget Meeting resumed at 4.25pm.

Cllr. P. Dunphy expressed sincere thanks on behalf of the local community to Mr. B. Mernagh, Mr. P.J Phelan and Water Services staff who responded on Christmas Day to a water leak in his area, and asked that this be conveyed to the staff.

Mr. Crockett, County Manager outlined to the members the main factors influencing the 2012 Budget. Total expenditure for 2012 is estimated as €68.8m, a reduction of €1.8m on the 2011 Budget. The local government fund allocation for 2012 will be €15.1m, a reduction of €1.1m on the 2011 allocation. Kilkenny County Council's rate is still the lowest in the Country, and is 21% lower than the national average. He referred the member to page 2 & 3 of his report which highlights the main issues affecting the 2012 Budget. He advised that the Road Works Programme will be presented to the members in Feb/March when the roads grants have been announced.

In relation to economic development, it is hoped that a lot of progress will be made in 2012. Considerable effort is being devoted to the objectives contained in the County's Economic Development Policy and the Invest Kilkenny Campaign.

The closure of Diageo will have a serious effect on Kilkenny. However the links with Suzhou are welcome.

The Council's end of year balance sheet shows a surplus of approx. €7m, which is made up of unspent development charges of €6.5m. These are now factored into the draft 2012 – 2014 Capital Budget. The deficit has been eliminated over the last ten years.

Mr. Crockett outlined to the members that the draft 2012 – 2014 Capital Budget shows a spend of €192m over all the projects. There is a record number of water service projects included in the Draft Capital Budget. All accumulated development charges have been assigned to the various projects. At the end of 2014 there will be no surplus development levies available. Details of the draft Capital Budget has been circulated for members information.

Contributions were made by Cllr's M.H Cavanagh, Ml. O'Brien, M. Doran, S. Treacy, P. Millea, A.M Irish. Members thanked the County Manager, Head of Finance and staff for all the work done in producing a balanced budget despite reductions in the Local Government Fund. A number of issues raised required

clarification:-

- Use of funds for RAS in the Capital A/C.
- Cost of surface dressing roads.
- No. of houses in RAS.

Mr. Mulholland and Mr. McCormack replied to the queries raised.

It was proposed by Cllr. M.H Cavanagh, Seconded by Cllr. Ml. O'Brien that the rate proposed of \le 52.31be reduced to \le 52.05 and that expenditure on local roads funding be reduced by \le 60,300.

Cllr. M. Doran proposed that the credit capital balance on RAS will be used to reduce the rates being levied on the business people. This was seconded by Cllr. P. Millea.

The County Manager advised the meeting that RAS savings accumulated over the last few years in the Capital Account and must be kept for future use on RAS houses. The Council cannot legally use this fund for the Revenue Account. Therefore the amendment proposed by Cllr. M. Doran, Seconded by Cllr. P. Millea is not a valid amendment.

Discussion ensued in relation to the use of RAS funds in the Capital A/C. It was proposed by Cllr. M. Doran, Seconded by Cllr. Ml. O'Brien that Kilkenny County Council write to the Minister for the Environment, Community and Local Government requesting approval to use the fund for other purposes other than the Rental Accommodation Scheme.

Cllr. P. Cuddihy advised members that a vote would now be taken on the proposal by Cllr. M. H. Cavanagh which was seconded by Cllr. Ml. O'Brien
