Africa Day 2018

The Council has been allocated a Grant of €8,500 by Irish Aid -Department of Foreign Affairs in respect of Africa Day activities in 2018. Africa Day will be celebrated on June 2<sup>nd</sup> /3<sup>rd</sup>. A programme of activities has been developed with Kilkenny's African Communities as follows:

CLÁR

The CLÁR Scheme for 2018 was notified to the Council on 16th March 2018. The Scheme is targeted at designated CLAR areas which have suffered population decline.

The Scheme has 3 Measures as follows:

Measure 1: Community Safety measures to access school and community facilities. Up to 90% of cost is funded subject to a min of  $\epsilon$ 1,000-max of  $\epsilon$ 50,000.

Measure 2: Play Areas/Multi Use Games Areas. Up to 90% of cost is funded subject to a min grant of €5,000 and a max of €50,000.

Measure 3: Registered First Responder Voluntary Groups- Application to be made directly to the Department.

The Council submitted 11 applications (10 under Measure 1 and 1 application under Measure 2) by the closing date of 30th April as follows:

#### Play Area Grant

The Department of Children and Youth Affairs (DCYA) has made available a national allocation of £250,000 in respect of innovative play areas for 2018. Local Authorities were invited to apply for funding of £20,000 which is maximum given to each Local Authority in respect of new and innovative play and recreation spaces or refurbishment or upgrading of existing play and recreation spaces and facilities This funding scheme was introduced in 2013. The evaluation committee comprises of staff from the Participation Play and Recreation and Culture Unit, DCYA and at least one other evaluator with relevant expertise.

The Council has submitted three proposals as follows:

### Town & Village Renewal Scheme 2018

The Town and Village Renewal Scheme for 2018 has been announced. Total funding of €15 million will be allocated nationally to up to 200 towns and villages this year. Selection of projects will be by means of a competitive process, initially at Local Authority level, with the final project selection being made by the Department of Rural and Community Development.

The Council may submit up to 12 applications. The Council is guaranteed approval for 4 projects.

The Council will be required to advertise for expressions of interest from towns/villages in their area and will select proposals to be developed into more detailed applications to be submitted to the Department by the end of June.

The final project selection will be made in July by the Department of Rural and Community Development. Successful projects will be expected to commence by year-end and can run throughout 2019.

#### **Grant Levels**

Up to 80% of the total cost of a project will be provided for any individual project. The minimum grant which is available is €20,000 and the maximum is, generally, €100,000. Up to 10% of the total cost may be provided in the form of "in-kind" contributions (e.g. land lease or voluntary labour); a minimum cash contribution of 10% will also be required.

A higher maximum of £200,000 will be considered for a number of projects where a robust case can be made demonstrating exceptionally strong economic benefit to a town.

### **Key Selection Criteria**

- Towns approved under the 2016 and/or 2017 Town and Village Renewal Scheme, the 2015 and/or 2016 REDZ Scheme will only be considered if all 2015/2016/2017 funding has been fully and satisfactorily expended by end-June 2018.
- Successful proposals will include activities which have clear positive economic impacts on the town, rather than just public realmtype actions
- Successful proposals will demonstrate close collaboration between communities and business interests in the design and delivery of proposed projects and must have the support of the Local Authority.

### **Types of Projects**

- Projects that support entrepreneurship (e.g. development of Enterprise Hubs, Hot Desk Facilities, Digital Hubs, Creative Hubs, training facilities).
- Integrated approaches to developing individual sectors within the town and/or its environs (e.g. artisan food hubs, craft hubs)
- Projects which demonstrate collaboration between town centre businesses and the surrounding area to produce economic benefit
- Targeted actions to tackle minor infrastructural deficiencies in access, services, site development works and other infrastructure that may be needed to support town centre housing and commercial development
- Tourism initiatives
- Enhancement of heritage and/or other community assets
- Town safety and accessibility enhancements

 Provision/enhancement of leisure facilities (e.g. Town Parks, walking trails)

The following types of activity are eligible for support, but will be considered a lower priority for towns with a population of over 1,000 people unless they can be shown to be an integral part of a higher priority project:

- Enhancement of streetscape and town environment
- Shop front enhancement
- Branding and promotion of the town/village to attract new customers and/or business investment
- Car parking improvements

The Council will shortly be advertising for expressions of Interest under the Scheme

An information night will also be held for interested groups.

### Healthy Ireland Funding

The Department of Health and Pobal invited Kilkenny LCDC to apply for funding under Round 2 of Strand 1 of the Healthy Ireland Fund (1 April 2018-31 March 2019). The invitation issued on 24th April. Both Local Community Development Committees (LCDCs) and Children and Young People's Services Committees (CYPSCs) are eligible to apply.

The maximum allocation to Kilkenny LCDC is €75,000. The maximum allocation to Kilkenny CYPSC is €37,500.

The primary aim of the Healthy Ireland Fund is to support innovative, cross-sectoral, evidencebased projects and initiatives that support the implementation of key national policies in areas such as obesity, smoking, alcohol, physical activity and sexual health.

The objectives of the Fund are:

 To raise awareness of, and support for, Healthy Ireland through the funding of

- community-based and national health promotion activities.
- To facilitate and resource cross-sectoral and partnership networks that promote health and well-being.
- To resource the development of locally-led, cross-sectoral strategies promoting health and wellbeing.
- To add value to existing health promotion initiatives through the provision of Healthy Ireland resources.
- To support the health and wellbeing of the most disadvantaged groups and areas and those experiencing significant health inequalities through long-term planning.

Both Kilkenny LCDC and Kilkenny CYPSC will be submitting applications to avail of both allocations. Kilkenny LCDC is currently finalising its Kilkenny Healthy Ireland Community Plan and the Kilkenny proposals will be based on that plan.

The closing date for the receipt of applications was initially Friday 11th May but has since been extended to Friday 25th May. The Kilkenny LCDC will makes its decision on the application for submission at its meeting to be held on 18th May.

Kilkenny County Council receives grants for Culture & Creativity Programme 2018

Kilkenny County Council has received an allocation of €96,750, from the Department of Culture, Heritage and the Gaeltacht and the Department of Housing, Planning and Local Government, to support the implementation of Kilkenny County Council Creative Ireland Activity Plans 2018. We have also received €5,000 towards our Decade of Commemorations programme, and up to €10,000 for a *Cruinniú na nÓg* festival, celebrating creativity in young people, on 23<sup>rd</sup> June. Further details will be announced shortly.

National Biodiversity Action Plan

Funding for local authorities in support of the implementation of Irelands third National Biodiversity Action Plan (2017 -2021)(NBAP) has been announced by the Department of Culture, Heritage and the Gaeltacht. In 2018 grant funding to a maximum amount of €8,000 will be provided to each local authority with a requirements to provide match funding. Each project proposed will be required to contribute towards the achievement of the objectives of the NBAP.

#### TOURISM & MARKETING

Tourism Training Day, Parade Tower

Kilkenny County Council's Tourism Department and Local Enterprise Office (LEO) combined forces to host a one day training programme on Thursday April 12th 2018 in the Parade Tower, Kilkenny Castle - entitled 'How to grow business

for Destination Kilkenny', which focused on management solutions for the hospitality and tourism sectors, concentrating on ways to grow revenue for tourism businesses through an understanding of collaborative selling, customer diversification, sales channels and market intelligence. A packed schedule was delivered and topics explored included destination selling, diversification, lead generation, nurturing the business and tracking for growth. The event was fully subscribed with 40 plus participating, including attendees from Kilkenny Tourism and #tastekilkenny. Feedback was overwhelmingly positive.

The Council is in the process of acquiring a agreement, at Turfmarket, property, by Graiguenamanagh and it is anticipated that same will be concluded shortly. The acquisition of this property will allow for the construction of a new 15 bay car park and public toilet on the site. It has been a long standing objective of the Council to increase the parking provision serving the commercial heart of the town and the identification and delivery of new off-street parking provision is defined as a policy action in the Graiguenamanagh Local Area Plan, 2009.

The provision of 15 additional car parking spaces within such close proximity to the town core and riverbank area will provide for a significant boost to the local economy. In addition, the closure of the public toilets on Convent Road has been an inconvenience to the local community in Graiguenamanagh and also for tourists and visitors to the town. The provision of a new modern toilet within close proximity to the town centre, with parking provision directly beside same, will address this issue and add to the amenity / hospitality offering.

The design stage for this project is now complete and the planning process under Part 8 of the Planning and Development Regulations has also commenced and documentation for same will be available for public inspection from mid May.

The Council has identified the current Town and Village Renewal Scheme rolled out by the Department of Rural and Community Development as a potential funding stream to deliver the construction stage of this project and an application for funding will be made shortly under same.

N25 New Ross Bypass

The design and construction phase of the PPP Contract is approximately two-thirds through, and the scheme remains on programme to open in 2019.

On the Kilkenny side of the Barrow Bridge, the edge sections of the deck have now been constructed on the first two approach spans while post tensioning and pouring of span 3 is ongoing on the Wexford side. The first deck segment of the central spans has been launched from pier 4 following the full installation of the form traveller system.

The central deck box for span 6 on the Stokestown side is progressing and the other approach spans on the Wexford side will follow over the coming months.

The construction of mainline pavement foundations continues to progress and pavement works will develop and expand significantly in the coming weeks. The current phase of the temporary traffic management on the N25 at Glenmore was introduced recently.

The full circulatory roundabout will be operational for this phase which is anticipated to be in place until mid-June. The L-7513 Ballyverneen Road remains closed and the new realigned road is also anticipated to open in May. Also on the Kilkenny side, the Ballyverneen Overbridge and Glenmore Underbridge are well underway and the overbridge to carry the disused Waterford to New Ross rail line is also progressing.

The Elected Members of the Municipal District of Piltown and a number of Council Officials recently undertook a site visit of the project.

N78 Castlecomer Bridge to Coolbaun South and Coolbaun North to Crettyard Pavement Improvement Scheme

This Scheme will provide for the strengthening of 6.73km's of carriageway, drainage and footpath improvement and other associated works and a grant allocation of €2,150,000 was secured for same. Tender Documents were issued to the Southeast Framework Panel on Monday the 30th April 2018 and the closing date for tender submissions is Friday the 18th May 2018. It is anticipated, subject to the necessary approvals that works will commence in late Q2 2018.

Local Infrastructure Housing Activation Fund Schemes in Kilkenny (LIHAF)

Kilkenny Western Environs Phase 1 Infrastructure Scheme (Total Cost £10.94 million)
The works required to remove the infrastructural impediment to enable the development of the Western Environs in Kilkenny City consists of the following key elements:

a) Construction of a roundabout on the N76 Callan Road at the intersection of the proposed Western Environs distributor road.

- b) 1.3km Western Environs distributor road, linking the N76 with the existing Circular Rd at Robertshill junction and the upgrade of the existing Circular Road from Robertshill to the R695 Kilmanagh Road.
- c) Construction of a roundabout on the R695 Kilmanagh Road at the proposed intersection with the Western Environs distributor road.
- d) 1.3km upgrade of the R695 Kilmanagh Road from the proposed intersection with the Western Environs distributor road to the north western extremity of the Western Environs footprint.
- e) Provision of Linear Park.

The Councils application under the Local Infrastructure Housing Activation Fund (LIHAF) was successful with grant funding of €5,070,000 awarded in March 2017 (this represents 75% of the Phase 1 Infrastructure contract costs – the remaining 25% of the contract construction costs and the land purchase costs to be funded by Kilkenny County Council).

The proposed road is single carriageway with lighting, footpaths and cycleways on both sides. Included in the road construction will be all the necessary services required for the future development of the area.

The procurement process for the appointment of a contractor for the road construction (a to d above), is continuing. A total of 8 construction companies have been shortlisted following Stage 1 of the procurement process, with Stage 2 (tender stage) due for publication on June 6th. Construction is planned to commence in Q3 2018. Projected scheme completion date is late 2019. Construction of the Linear Park will follow after the completion of the road scheme.

Ferrybank Neighbourhood Park (Total Cost €0.64 million)

Tenders for the detailed design of the Ferrybank Neighbourhood Park were submitted on March

23rd. Following assessment of tenders the contract for the appointment of a design team has been awarded to Cunnane Stratton Reynolds Landscape Architects. The detailed design, and appointment of works contractor, is expected to take a number of months with construction of the Park planned to commence in Q4 2018. This park will be funded by a combination of LIHAF funding with matching funding from Kilkenny and Waterford Local Authorities.

**Abbey Quarter** 

Public Consultation of proposals for the development of a temporary car and coach park on the Abbey Quarter site commenced on Wednesday 16th May. The proposed temporary development will see the provision of 132 car parking spaces and 7 coach parking spaces on the area of the site between the River Breagagh and St Francis Bridge. It is proposed that the development will be for a period of up to 5 years, while development proposals for this site are being considered in line with the provisions of the Abbey Quarter masterplan. The proposed development will allow the site to be used in the short term to the benefit of the local community and the local economy.

The provision of coach parking in this area will provide an alternative to the current coach parking facility at Kilkenny Castle, and will provide much needed parking facilities for the tourist attractions at the Northern End of the Medieval Mile including St. Canices Cathedral, Rothe House and the Smithwicks Visitor Experience.

The provision of car parking will also facilitate visitors to the Northern end of the Medieval Mile, as well as future occupiers of the first buildings to be developed on the Abbey Quarter Site.

Details of the proposed development will be on public display from Wednesday 16th May to Wednesday 13th June 2018. ### Capital Delivery 2018

The Minister for Housing by letter dated 18th April 2018 notified Kilkenny County Council of its revised delivery targets under Rebuilding Ireland i.e. 599 units for the period 2018 to 2021 and a specific target of 133 units for 2018.

During the first four months of 2018 a number of schemes advanced as follows:

- Construction underway on a rural house at Barna, Freshford. Expected completion date July 2018.
- Construction in progress on the conversion of Greensbridge B&B and adjoining house to 5 self contained 1 bed units. Expected completion date August 2018.

- Purchase of 7 houses sale agreed to date in 2018.
- Part 8 planning permission was granted for 17 Units at Main St Piltown at the April Council meeting.
- A consultation evening was held in the Canon Malone Hall on the 11th April for the Part 8 proposal for 22 Units at Station Avenue, Ballyragget - Part 8 on Agenda for May Council Meeting.
- Stage 2 approval was received for 17 units at Piltown and 22 at Station Avenue, Ballyragget.
- Stage 4 approval was received for 38 Houses at Bolton, Callan. Pre-award discussions have commenced with the contractor.
- Tenders received for 1 house at St Mary's Crescent, Hebron Road.
- Construction work on 4 houses at Wetlands, Kilkenny was completed and the houses were allocated.
- A design team was appointed to work on 2 group homes at Blackstaff, Callan and Cloghabrody, Thomastown.

### **Housing Needs Assessment 2018**

We have been informed by the Department of Housing, Planning and Local Government that each Housing Authority is required to prepare a Summary of the Social Housing Assessments (s.21 Housing (Miscellaneous Provisions) Act 2009) for its administrative area. This Summary is now carried out annually and the counting date this year is 11th June 2017. Deadline for the return of summary to the Department is 29th June, 2018.

This statutory Assessment will identify the number of qualified households on our Housing List whose housing need have not been met. This list does not include those households on a transfer list or in accommodation provided under RAS or HAP. Kilkenny County Council has made contact with all applicants in recent weeks and are currently reviewing each application. We will be contacting all applicants again in the coming weeks to inform them of the outcome of their review.

### New Rent Scheme and Rent Review 2018

Members are reminded of the pending rent review to be carried out in 2018 for all our tenants. It is hoped to have the new rents in place in July 2018.

In addition, the proposed new Rent Scheme was discussed at the Strategic Policy Committee that was open to all elected members to attend on Thursday 29th March. The purpose of the revised Rent Scheme is to remove the current anomalies in the two rent schemes and remove certain historical charges in addition to rent. It is estimated that there will be no surplus rental income arising from the rent review in 2018 as a number of reductions must be provided for in order to amalgamate both rent schemes.

Vacant Sites: There has been considerable interest generated as a result of a number of sites included on the Council's Vacant Site Register. Specifically the inclusion of land that is zoned residential but currently being used for agricultural purposes.

Following discussion at the SPC3 Planning Meeting and at the Council Meeting, the Council's legal advisor was asked to advise on the definition of 'vacant or idle' land under the Urban Regeneration and Housing Act 2015.

Following receipt of the legal advice, a review of the Council's vacant sites register has been undertaken and a number of sites have now been removed from the register.

Valuations have been carried out on the remaining sites on the register and notices of these valuations and the inclusion of the sites on the register will be sent to land owners in the coming weeks.

County & City Development Plans: The Council published the statutory notice on the 20th April signifying the commencement of the review of the County & City Development Plans.

An issues paper has been published for the initial public consultation exercise up until the 15th June 2018.

The first of three public meeting was held in the City Hall on the 10<sup>th</sup> May where between 50 & 60 people attended.

Two further meetings are planned for Mullinavat on Wed 16th and in Ballyragget on Tuesday 22nd of May.

Having secured funding of €40,000 from the Department of Communications, Climate Action and Environment under the Anti-Dumping Initiative, Kilkenny County Council will be using some of this funding to arrange a "Free Mattress Drop-Off Day" on Saturday 16th June 2018 from 12.00 to 16.00 at the Dunmore Civic Amenity Site. #### **Graveyard Grant Scheme**

Some of the remaining applications require further information and pending the receipt of same, they will be considered for funding at a later stage.

#### **Amenity Grants**

#### **Enforcement Action**

The Environment Section secured one prosecution with costs awarded to the Council under the Litter Act in the last month. Two further prosecutions are pending and are due to be heard in court shortly. The Environment Section also decommissioned and removed one unauthorised Pay to Use Facility. The Enforcement Team remains committed to tackling all illegal dumping and illegal activities around the city and county.

### Granny Recycling & Waste Disposal Centre

The Granny Recycling and Waste Disposal Centre officially opened on 4th May, 2018. The opening was officiated by Cllr Fidelis Doherty, Chair of the Piltown MD and attended by Minister John Paul Phelan, Cathaoirleach Cllr. David Fitzgerald and elected members from the Piltown MD, along with members from SPC5 Environment. Centre has been operating successfully since the 15th November last, accepting a wide variety of waste for recycling and disposal. While the Centre is operated by Crystalhill Inns Ltd, t/a CHI as a privately run centre, Kilkenny County Council makes an annual contribution towards the operational costs of the facility.



#### **LAWCO**

Continuing to work with communities, LAWCO is participating in the Big Spring clean up concentrating on our Rivers in Carlow and Kilkenny, working with KCLR radio and schools art competition, which will conclude at end of May 2018, with entries posted on Social Media.

LAWCO have also embarked on an awareness raising initiative in the schools on the importance of water quality and communities, around the River Bregagh which is a priority water body. Following on from the WERLA anti-dumping initiative in Sept 2017, removal of plastics from the River Barrow, Graignuenamanagh Boys National School have removed plastic bottles from their school environment. Participating in same initiative again this year extended to River Nore. LAWCO is also participating with Inistioge Entente Floral on water quality.

### STUDENT ENTERPRISE PROGRAMME

All participating Kilkenny students were winners at the National Final this year, with the project 'Life Arm Assist' from CBS Kilkenny scooping the first prize in the Intermediate category. Students from Coláiste Éamann Rís Callan were presented with Best Display in the Junior Category while 'Kat Food' also from CBS Kilkenny won the Special Merit Award in the Senior category. The students were presented with their awards on stage by the Minister for Trade, Employment, Business, EU Digital Single Market and Data Protection, Pat Breen T.D. and Sheelagh Daly, Chair of the Local Enterprise Offices.

The winning students in the Intermediate category were: Edward Daly, John O'Brien and Matthew O'Sullivan who worked under the guidance of their teacher, Mr. Pat Downey to develop their awarding winning innovative product "Life Arm Assist". They developed an innovative hydraulic ram that replaces the life arm stabilizer on the back of a tractor. It has been developed as a labour saving device but also reduces the incidence of serious accidental injury.

In the Senior Category, the Special Merit award was presented to KAT Food project developed by Conor McCarthy and the late Colm Dunne, under the guidance of Ms. Anna Culleton also from CBS Kilkenny.
