2. (a) Housing & Other Disposal - Tithiocht & Diuscairt Eile

(i) It was proposed by Cllr. Pat Fitzpatrick, seconded by Cllr. Michael McCarthy and agreed:

(b) Planning - Pleanail

(i) Taking in Charge: Riverside Park, Urlingford

It was proposed by Cllr. Mary Hilda Cavanagh, seconded by Cllr. Michael McCarthy and agreed that:

"We, the Members of Kilkenny County Council approve the initiation of proceedings for the taking in charge of the following developments in accordance with Section 11 of the Roads Act, 1993 and in compliance with Section 180 of the Planning & Development Act, 2000 as amended by Section 59 of the Planning & Development Act 2010."

Development: TC145 - Riverside Park, Urlingford, Co. Kilkenny

(ii) Chief Executive's Report on Submissions to Variation 3 to the Kilkenny County Development Plan

Mr. Denis Malone, Senior Planner presented the Chief Executive's Report on the proposed Variation No. 3 to the Kilkenny County Development Plan 2014-2020. He advised that it is proposed to incorporate the expired Local Area Plans for the areas of Piltown, Fiddown and Gowran into the County Development Plan with settlement boundaries in accordance with Section 3.3.5.1 of the County Development Plan and to extend the settlement boundary of the Ballyragget Area in order to facilitate housing development.

He advised that six submissions were received following public display and it is recommended that there is no change to the proposed variation as published.

It was proposed by Cllr. Melissa O'Neill, seconded by Cllr. Maurice Shortall and agreed that:

"We the members of Kilkenny County Council, having considered the proposal to make Variation 3 to the Kilkenny County Development Plan 2014-2020 under Section 13 of the Planning & Development Acts 2000-2016, and having considered the Chief Executive's Report as circulated on the 6th March, prepared in accordance with Section 13 (4) of the above Acts, the recommendations as set out in the Chief Executive's report, and with our decision made at a meeting of Kilkenny County Council held on the 12th March 2018, do hereby resolve to vary the Kilkenny County Development Plan in accordance with Proposed Variation 3."

Cllr. David Kennedy requested clarification on the status of planning permissions granted in these areas. Mr. Malone advised that the Variation does not affect any current permission.

(iii) Chief Executive's Report on Submissions to Variation 5 to the Kilkenny City & Environs Development Plan

Mr. Denis Malone, Senior Planner presented the Chief Executive's Report on the proposed Variation No. 5 to the Kilkenny City & Environs Development Plan 2014-2020. He advised the Members that the purpose of Variation No. 5 to the Kilkenny City & Environs Development Plan is to provide the necessary overarching policy framework to allow for temporary parking in the Masterplan area notwithstanding the text of the Masterplan in Section proposed variation is a measure application/applications under Part 8 for temporary or meanwhile parking within the Abbey Quarter. It does not form part of the long term vision for the site. The opportunity of temporary uses was identified in the Urban Design Criteria & Development Code which was approved by the Council in January. The proposed variation was on public display and twelve submissions were received. It is recommended that there is no change to the proposed variation as published.

Queries were raised by Cllrs. P. Fitzpatrick, D. Kennedy, D. Fitzgerald, MH. Cavanagh, M. Noonan, M. O'Neill, T. Breathnach in relation to the following:

- Number of spaces available on site for parking.
- Clarify period of temporary use/"Meanwhile" use.
- Clarify status of provision of housing on the Northern end of site.

- Need to commence review of Mobility Management Plan for the City, reduce dependency on car parks, content of some of the submissions to be included in Review of Mobility Management Plan.
- HGV Management Plan.
- Other Car Parks underutilised.
- Include provision of spaces for all types of disability.
- Pedestrianisation of High Street.

Ms. Mulholland advised that there is a commitment to provide Social Housing on the site. There are issues to be addressed in relation to unit cost which is very high and also the provision of sports hall and parking for the houses. Mr. Butler advised that we will be going out to tender for Consultants for the Mobility Management Plan.

Mr. Malone responded to the other queries and advised that when Part 8 application comes before the Members for approval for temporary use that the time period will be included in the application. It is a matter for members to approve Part 8.

It was proposed by Cllr. Matt Doran, seconded by Cllr. Pat Fitzpatrick and agreed that:

"We the members of Kilkenny County Council, having considered the proposal to make Variation 5 to the Kilkenny City & Environs Development Plan 2014-2020 under Section 13 of the Planning & Development Acts 2000-2016, and having considered the Chief Executive's Report as circulated on the 6th March, prepared in accordance with Section 13 (4) of the above Acts, the recommendations as set out in the Chief Executive's report, and with our decision made at a meeting of Kilkenny County Council held on the 12th March 2018, do hereby resolve to vary the Kilkenny City & Environs Development Plan in accordance with Proposed Variation 5."

- 15 members voted in favour of the proposed Variation:

The proposed variation was passed.

- (iv) Part 8 for Waterford to New Ross Greenway &
- (v) Part 8 for Waterford to New Ross Greenway at Aylwardstown

Mr. Sean McKeown gave a PowerPoint presentation on the Waterford to New Ross Greenway. He explained the rationale for the two Part 8 Proposals. In his presentation he outlined the following:

- Proposal before the Members and details of route.
- Definition of Greenway, current National Policy and details of other Greenways.
- Discussion with Iarnród Éireann.
- Existing condition of the track.
- Outlined the proposed development work and location of works.
- Details given on the Aylwardstown Section.
- Submission received during the Part 8 application process, issues raised in the submission.

Mr. McKeown referred to the two Part 8 reports issued by the Chief Executive and recommended to the Members that approval to both Part 8's be approved.

Contributions were received from Cllrs. M. O'Neill, D. Kennedy, P. Dunphy, T. Breathnach, E. Aylward, G. Frisby, F. Doherty and M. Noonan.

Issues raised by Members related to:

- Concerns regarding privacy for householders and landowners.
- Responsibility for maintenance of the track, fencing etc.
- Tenure of lease from Iarnród Éireann.
- Provision of car parking for walkers.
- Agreement on accommodation works.
- Connectivity with other Greenways.
- Accommodation works required to negotiate the New Ross ByPass.
- NPF aspiration for re-instatement of old railway line.
- Off road use is not feasible.
- Welcome the discussions already undertaken with the farming communities.
- Change name to "Kilkenny Greenway".

Mr. Sean McKeown responded to all issues raised.

It was proposed by Cllr. Melissa O'Neill, seconded by Cllr. Ger Frisby and agreed by 19 Members that:

"We the members of Kilkenny County Council approves Part 8 in accordance with Section 179 of the Planning & Development Act 2000 as amended and Part VIII of the Planning & Development Regulations 2001, as amended, for the Waterford to New Ross Greenway, as circulated."

It was proposed by Cllr. Pat Dunphy, seconded by Cllr. Ger Frisby and agreed by 18 Members that:

"We the members of Kilkenny County Council approves Part 8 in accordance with Section 179 of the Planning & Development Act 2000 as amended and Part VIII of the Planning & Development Regulations 2001, as amended, for the Waterford to New Ross Greenway at Aylwardstown, as circulated."

Cllr. Melissa O'Neill voted against this proposal.

(vi) Proposed Material Contravention to County Development Plan in relation to Planning Application Ref. 17/706 on N76.

Mr. Denis Malone presented the Chief Executive's Report on the proposed Material Contravention of the Kilkenny County Development Plan 2014-2020 in relation to Planning Application P17/706 for development at Tullamaine [Ashbrook] Callan, Co. Kilkenny. He advised that the application is proposing to close off four entrances onto the National Road N76 and utilise an existing farmyard access to serve the proposed house. This will be a significant benefit to Road Safety.

Concerns were expressed by Cllr. Maurice Shortall in relation to creating precedent for other proposals for development onto National Roads.

It was proposed by Cllr. Mary Hilda Cavanagh seconded by Cllr. Matt Doran and agreed that:

"That in accordance with Section 34(6) of the Planning and Development Act 2000, as amended, a Decision to Grant Planning Permission shall be made, subject to appropriate conditions, to:

Sean Maher, c/o Brendan Moore, 53 The Fairways, Old Golf Links Road, Kilkenny to comprise as follows:

Construction of a two storey dwelling detached garage, vehicular entrance and access driveway, bore well, wastewater treatment system and soil polishing filter and all associated site works at Tullamaine (Ashbrook), Callan, Co. Kilkenny."

(c) (i) Severe Weather Report

Mr. Tim Butler gave a PowerPoint presentation on the recent severe weather and Storm Emma over the period 28th February, 2018 to 5th March, 2018.

In his presentation he gave an overview on the following:

- Preparations for the event, early warnings, severe weather team activated, call centre set up, all vehicles deployed and grit distributed to strategic locations.
- Severe weather details of weather over the week and extent of snow in the various locations, effects caused to communities and actions taken to assist communities, farming and other agencies, details of calls taken over the period.
- Clearing of roads, availability of salt, status of the road network over the period, number of vehicles used by the Council and Contractors.
- Assistance received from Defence Forces, Fire Service, Civil Defence, IFA and farming communities.

Cathaoirleach thanked Mr. Butler for his leadership during this difficult period and all the staff and communities who assisted to ensure that all citizens were looked after.

Contributions were also received from Cllrs. Fitzpatrick, Aylward, Noonan, P. O'Neill, Kennedy, Breathnach, Dunphy and Shortall.

All Members acknowledged the work of staff, Defence Forces, Emergency Services and all volunteers who assisted in any work to clear snow and to ensure that neighbours were safe. Information was readily available and kept up to date on social media.

Issues raised by members related to:

- Funds to repair roads.
- Recoupment of costs incurred during the severe weather period.

Cllr. David Fitzgerald advised that he intends to host a reception to recognise the efforts made by all.

Members agreed with this proposal.

(e) Community & Culture - Watershed

Cathaoirleach welcomed Mr. Dermot Gaynor and Ms. Tina Dowling to the meeting. Mr. Dermot Gaynor, Chief Executive of the Watershed gave a Powerpoint presentation on the operation of the Watershed for 2017. In his presentation he outlined to the Members the following:

- Range of activities provided.
- Number of visits/Membership.
- Operational surplus achieved in 2017.
- Details of sources of income received.
- Breakdown of operational costs.
- New activities introduced during 2017.

Cllr. David Fitzgerald thanked Mr. Gaynor for his presentation. He thanked Mr. Gaynor for his work with the Watershed since it opened nine years ago and wished him well as he leaves his job. He welcomed Tina Dowling who is taking over as Chief Executive.

Contributions were also received from Cllrs. M. Doran, M. Noonan, P. O'Neill, P.. Fitzpatrick, D. Kennedy, T. Breathnach & M. O'Neill in relation to the following:

- Ongoing development of the leisure centre.
- Introduction of new sports.
- Enthusiasm of staff and Board of Directors.
- No burden on the Council for the operational costs.
- Assistance given to many clubs and communities over the years.

Mr. Martin Prendiville on behalf of Ms. Colette Byrne, Chief Executive thanked Mr. Gaynor for his service with the Watershed and wished Ms. Tina Dowling every success in her new role as Chief Executive.

At this stage Cllr. Malcolm Noonan requested that the presentation by LEO be put back as an item on the Council Agenda.

Mr. Prendiville advised that the presentation was circulated to all Members.

(f) (i) Annual Financial Statement

Mr. Prendiville advised Members that the Elected Members are required to approve the Unaudited Accounts and approve excess expenditure for 2017. He advised that the audit of the Accounts will commence in a few weeks time.

Mr. Prendiville advised that the total expenditure for 2017 was €79m. Additional income was received from the NPPR. This is once off income and will not be available for 2018.

There has been continuous emphasis on the collecting of all income and arrears have decreased by approx. 50% over the years. There was additional expenditure in a number of areas but this was offset by additional grants and other income. A balanced position was maintained for 2017.

Long term debtors increased by €1.3m and this is due to new mortgage loans being issued. 47 loans were issued during 2017.

Mr. Prendiville further advised that the closing balance on the Capital Account is €2.7m at 31st December, 2017. The overdraft facility was not used during 2017. He advised that the three year capital budget for 2018-2020 is being prepared and will be presented to the Council in May 2018.

Mr. Prendiville thanked the Finance Staff for their work on preparing the final accounts.

As it was 5.55 p.m. it was proposed by Cllr. Eamon Aylward, seconded by Cllr. Maurice Shortall and agreed to suspend Standing Orders to finish Item 2 (f) (i).

Cllr. David Fitzgerald thanked all staff for their work in maintaining a balanced budget for 2017 and achieving a surplus of €5,431.

Cllr. Pat Fitzpatrick welcomed the high percentage in the collection of all incomes and thanked the staff involved.

In advance of taking the resolutions Mr. Prendiville advised that the Excess Expenditure of approx. &cupenstable10m in 2017 has been offset by the payment of additional grants and other income. There was a surplus of &cupenstable5,431 in the overall year.

It was proposed by Cllr. Pat Fitzpatrick, seconded by Cllr. Maurice Shortall and agreed:

"That Kilkenny County Council hereby approves of Excess Expenditure for year ending 31st December, 2017 as follows in accordance with S104(2) Local Government Act 2001:
