2. (a) Housing & Other Disposal – Tithíocht & Díuscairt Eile

(i) It was proposed by CIIr. Andrew McGuinness seconded by CIIr. Martin Brett and agreed:

"That, in accordance with the provisions of Section 183 of the Local Government Act, 2001, Kilkenny County Council hereby approves of the disposal of its interest in a site at Hebron Industrial Estate, Hebron Road, Kilkenny, as identified on the enclosed map as Site B, to Dunreidy Engineering Ltd, Unit 53 Hebron Industrial Estate, Kilkenny, for the sum of €337,000 (three hundred and thirty-seven thousand euros). (b) Planning

(i) Part 8: Ormonde Street Enhancement

Mr. Tim Butler presented the Chief Executive's Part 8 Report on the Urban Enhancement and Improvements for Ormonde Street, Kilkenny. He outlined the proposed works included in the Part 8. Part 8 was advertised in June 2019 for public consultation. Three submissions were received and two responses were received from the Statutory Agencies. The report outlines a summary of the issues raised and the Chief Executive's response to them. Mr. Butler recommended to the Elected Members that the proposed development be proceeded with.

Contributions were received from CIIrs. John Coonan and Malcolm Noonan in relation to the proposed works, removal of trees, cycle lane and derelict buildings. Mr. Butler responded to the issues raised.

It was proposed by CIIr. John Coonan, seconded by CIIr. Martin Brett and agreed:

"We the Members of Kilkenny County Council approves the proposed Part 8 in accordance with Section 179 of the Planning & Development Act 2000 as amended and Part VIII of the Planning & Development Regulations 2001, as amended for the proposed Urban Enhancement & Improvement – Ormonde Street, Kilkenny, as circulated."

(ii) Part 8: Proposed Housing at Parcnagowan

Ms. Mary Mulholland presented the Chief Executive's Part 8 Report on the proposed development of six houses at Smithsland South, Kilkenny [adjacent to Parcnagowan].

Ms. Mulholland advised the Members that this is a brownfield site. Access to the site would be through the Parcnagowan Estate. As the services in the Parcnagowan Estate have not been taken in charge to-date and agreement was not received to access the site through the Estate, it is recommended to the Members that this proposed development does not proceed at this stage as it is premature. When the Parcnagowan Estate is taken in charge a new statutory planning process will be undertaken. She recommended to the Members that the proposed Part 8 development be refused.

Contribution was received by CIIr. Andrew McGuinness in relation to the views of the residents and request for meeting with the residents affected by the proposed development.

It was proposed by CIIr. Andrew McGuinness, seconded by CIIr. Tomás Breathnach and agreed:

"We the members of Kilkenny County Council agree the proposed Part 8 in accordance with Section 179 of the Planning & Development Act 2000 as amended and Part VIII of the Planning & Development Regulations 2001, as amended to refuse the proposed development of 6 houses at Smithsland South, Kilkenny as circulated."

(c) (i) Anti-Litter/Anti-Graffiti Awareness Grants

Mr. Sean McKeown presented his report on applications for funding under the Anti-Litter/Anti-Graffiti Awareness Grant Scheme 2019. He advised Members that 14 applications were received. A budget of \in 6,825 is available to distribute to local communities. Two applications do not fit the criteria of the grant scheme. Mr. McKeown recommended that grants be awarded to 12 grants as listed in the report.

It was proposed by CIIr. Fidelis Doherty, seconded by CIIr. Pat Fitzpatrick and agreed that:

(ii) Climate Adaptation Strategy

Mr. Sean McKeown gave a PowerPoint presentation on the Draft Climate Change Adaptation Strategy 2019-2024. In his presentation he gave an overview on the following:

- Process to-date
- Challenges for Implementation
- Adaptation Action Headlines: Energy & Building

 - Resource Management

Mr. Frank Stafford gave a PowerPoint presentation on the actions and sub actions under the Adaptation Action Headlines as referred to in the previous presentation. Details of all the actions are listed in the document which was circulated with the Agenda.

Mr. Stafford advised that there are 95 actions and 116 sub actions for the period 2019-2024. He gave an overview on these actions for each of the Headline Areas.

Cathaoirleach thanked Mr. McKeown and Mr. Stafford for the detailed overview on the Strategy.

Contributions were received from CIIrs. Malcolm Noonan, John Brennan and Tomás Breathnach.

Issues raised by Members were as follows:

- Challenges to deliver on the actions.
- Green Procurement.
- Mobility Management Plan and Bio-Diversity Plan.
- Need for Local Authority to lead the change.
- Education and Awareness.
- Monitoring and Evaluating the Actions.

Mr. Sean McKeown responded to the points made and advised that SPC 4 will be reviewing/monitoring the delivery of the Actions on a quarterly basis.

It was proposed by CIIr. Eamon Aylward seconded by CIIr. Michael McCarthy and agreed:

"We the members of Kilkenny County Council having considered the proposal Pursuant to the provisions of the Climate Action and Low Carbon Development Act 2015 and the National Adaptation Framework (NAF), 2018. Kilkenny County Council resolves to approve the Kilkenny County Council Climate Change Adaptation Strategy 2019-2024, having considered the draft strategy, the contents of the CE report on submissions received during the period of consultation and the SEA and AA Screening Reports carried out in accordance with the requirements of the SEA Directive (DIR 2001/42/EC) and Article 6(3) of the EU Habitats Directive (Directive 92/43/EEC."

(d) (i) Traveller Accommodation Programme 2018 – 2023

Ms. Mary Mulholland presented the Draft Traveller Accommodation Programme 2019-2024 for approval by the Members. It is a reserved function to adopt a programme every five years. Workshop was held for Members on 26th July, 2019.

The draft Programme was put on public display for four weeks. Consultation was held with Local Traveller Consultative Committee, Housing SPC, agencies on the Traveller Interagency Group, Traveller & Local Development organisations and other groups that have an interest in the provision of Traveller Services. Engagement was also had with Young Travellers through Ossory Youth.

Ms. Mulholland outlines that to be eligible to be included in the programme the family must be residing in the functional area of Kilkenny County Council and are included in the Social Housing Assessment data gathered in June 2018. There are 41 families approved for accommodation and a projected need for a further 25 households. Total of 66 households for the period 2019-2024. Kilkenny County Council has exceeded the targets included in the last Traveller Accommodation Programme and Ms. Mulholland acknowledges the work and support of all the Housing staff in achieving this.

Contributions were received from CIIrs. John Coonan, Malcolm Noonan, Eugene McGuinness and Andrew McGuinness in relation to the following:

Ms. Mary Mulholland and Mr. Sean McKeown responded to all the issues raised.

It was proposed by CIIr. John Coonan seconded by CIIr. Malcolm Noonan and agreed:

"That Kilkenny County Council approves the adoption of the proposed Traveller Accommodation Programme 2018-2023, as list circulated to the Members."

(e) (i) Annual Financial Statement 2018

Mr. Martin Prendiville presented the Audited Annual Financial Statement for 2018. He advised that the Audit for 2018 is completed and there is no change to the Financial Statement which was presented to Members in March, 2019.

It was proposed by CIIr. Mary Hilda Cavanagh, seconded by CIIr. Eamon Aylward and agreed that the Audited Annual Financial Statement for 2018 be noted.

(ii) Local Government Audit Report

Mr. Prendiville presented the Statutory Audit Report for the year 2018. He advised Members that a number of issues were raised during the Audit. Management have responded to each item and reported on the actions taken to address the issues.

CIIr. Malcolm Noonan raised a query on the assets of the Civic Trust and outsourcing the operation of Butler House. Ms. Byrne responded to the queries.

It was proposed by CIIr. Mary Hilda Cavanagh, seconded by CIIr. Eamon Aylward and agreed that the Statutory Audit Report for the year ended 31st December, 2018 be taken as read and noted.

(iii) Local Property Tax

Ms. Colette Byrne, Chief Executive presented her report on the Local Property Tax. She referred to the briefings provided to all the Members on the need to increase the Local Property Tax by 15%.

She advised the Members that there are significant challenges facing the Council for 2020 budget. She encouraged Members to adopt a 15% increase on the Local Property Tax so that there will not be a significant impact on the discretionary spending which will impact on the level of services/projects provided by the Council/communities throughout the City and County.

Contributions were received from CIIrs. Andrew McGuinness, Mary Hilda Cavanagh, Denis Hynes, Malcolm Noonan and Eugene McGuinness.

Members voiced their concerns on:

- The impact the increase would have on individual households.
- No increase on commercial rates.
- Collection of outstanding arrears.
- Impact on the delivery of services, reduction in the level of funding to communities.
- Scale back projects.

Mr. Prendiville responded to the issues raised. He outlined the increase on the various bands of the Local Property Tax:

Properties in Band 1:	0.26 c per week
Properties in Band 2:	0.52 c per week
Properties in Band 3:	0.91 c per week

90% of properties in Kilkenny are in these three bands.

Ms. Byrne advised Members that serious consideration is given to all capital projects. The provision of funds from the Council are used to leverage grants from Department and other State Agencies.

It was proposed by CIIr. Andrew McGuinness, seconded by CIIr. Mary Hilda Cavanagh that the Local Property Tax be increased by 15%.

CIIr. Malcolm Noonan proposed an amendment that the Local Property Tax be increased by 5%. There was no seconder.

The proposal was put to a vote.

Ms. Colette Byrne presented her Report. Cllrs. Pat Fitzpatrick, Fidelis Doherty, John Brennan and Mary Hilda Cavanagh raised queries in relation to CLAR Funding and the criteria for designating areas. Members requested that the Scheme be revisited.

Mr. Butler responded and advised that the Department has indicated that a review be carried out.

At this stage of the meeting the fire alarm went off, all present were evacuated from the building.

12. Notices of Motion from other local authorities seeking support of Kilkenny County Council

It was proposed by CIIr. Michael Delaney, seconded by CIIr. Denis Hynes and agreed that Notices of Motion 16 (19), 17 (19), 18 (18) and 19 (19) be taken as read and noted.

16 (19) Kerry County Council

"That we write to the Minister for Defence and An Taoiseach asking that the long overdue medals for gallantry and distinguished service specifically for the Irish soldiers of A Company who served at Jadotville in 1961 be awarded. These medals were promised by former Taoiseach Enda Kenny in his final days in Office and still they have not been received."

17 (19) Kerry County Council

"Considering obligations under the Good Friday Agreement {GFA], this Council calls on the Irish Government to bring the Equal Status Act in line with legislation in the 6 County state and include 'political belief' as an unlawful ground for discrimination."

18 (19) Leitrim County Council

"At the July Meeting of Leitrim County Council that the Members unanimously agreed to write to Minister for Agriculture to oppose the EU Mercosur Trade Deal."

19 (19) Waterford City & County Council

"That Waterford City & County Council in keeping with the objective of making Waterford a fair employment area agrees with and endorses the right of all employees to be represented individually and/or collectively by a trade union if they so wish. We would expect and encourage all Employers and their representative organisations in Waterford City & County to fully recognise this basic fundamental human right and so not intimidate, harass or threaten the continued employment of those exercising this right."
