**6. Fógra Foriarratais in ainm an Comh. Andrew McGuinness, dar dáta 22 Eanáir, 2018.
Notice of Motion in the name of Cllr. Andrew McGuinness received 22nd January, 2018:**

"That this Municipal District, in consultation with the residents association, produce a costed plan to refurbish the footpaths in Glendine Heights, Kilkenny, in order to deal with the following issues:

- 1) Adjacent sections of concret at different heights (up to 2 inches in places), resulting in trip hazards.
- 2) Uneven footpaths (lifted by roots of trees), resulting in trip hazards.
- 3) Poor condition of footpath surfaces promoting the growth of thick layers of moss, resulting in slip hazards.

And that we implement that plan as soon as possible."

**7. Fógra Foriarratais in ainm an Comh. David Fitzgerald, dar dáta 29 Eanáir, 2018.
Notice of Motion in the name of Cllr. David Fitzgerald received 29th January, 2018:**

"Kilkenny MDC establish a special designation for Irishtown as "Baile na Gael" to include bilingual shopfronts, street signage and special destination to encourage regeneration of this unique historic and cultural area of Kilkenny City."

**8. Fógra Foriarratais in ainm an Comh. Patrick McKee, dar dáta 30 Eanáir, 2018.
Notice of Motion in the name of Cllr. Patrick McKee received 30th January, 2018:**

"The Members of Kilkenny City Municipal District call on Kilkenny Local Authority to carry out an analysis and costing for the provision of public lighting along the public footpath at Loughboy Park, Kilkenny City".

**9. Fógra Foriarratais in ainm an Comh. Malcolm Noonan, dar dáta 30 Eanáir, 2018.
Notice of Motion in the name of Cllr. Malcolm Noonan received 30th January, 2018:**

“(a) Seek appropriate funding to develop a lighting scheme for Loughboy Park in Kilkenny City. Recognising that this is a widely used shared amenity in one of the most populated areas of the City and that the service ducting and cables for a lighting scheme are already in place, we request that the engineering section would advance such a project as a matter of priority given the challenges posed by inadequate lighting in the park.

(b) Engage in a collaborative process with all residents in the area to determine how the park is currently used, who uses it and how it could be improved as a community amenity for all ages to enjoy.”

**10. Fógra Foriarratais in ainm an Comh. David Kennedy, dar dáta 27 Feabhra, 2018.
Notice of Motion in the name of Cllr. David Kennedy received 27th February, 2018:**

“That the Municipal District of Kilkenny City East look into the possibility of putting a cycling lane from Thomastown town centre to Jerpoint Abbey.”

**11. Fógra Foriarratais in ainm an Comh. Andrew McGuinness, dar dáta 31 Eanáir, 2018.
Notice of Motion in the name of Cllr. Andrew McGuinness received 31st January, 2018:**

“That this Municipal District would begin the process of setting out a traffic management scheme for the Ballyfoyle Road, from its junction with the Castlecomer Road to, at minimum, the Ring Road Bridge. Such a scheme would provide for extending the cycle track network along the Ballyfoyle Road (to the Ring Road) together with the completion of footpaths on both sides of this section of the Ballyfoyle Road as, currently, there are long stretches within this area of the City realm that have no footpath. That the design already started by Kilkenny County Council be presented to members for agreement.

Also, that problematic areas, already identified and brought to engineer’s attention, receive macadam works and surface dressing to enhance driving quality and these measures be included as part of 2018 Roadworks Programme to be agreed with Municipal District Members.

Additionally, a footpath extension to Brooklawn housing scheme.

That Pike Lane be realigned to improve visibility and create pull in refuge areas.”

**12. Fógra Foriarratais in ainm an Comh. Malcolm Noonan, dar dáta 31 Eanáir, 2018.
Notice of Motion in the name of Cllr. Malcolm Noonan received 31st January, 2018:**

“That Kilkenny Municipal District Council would collaborate with other relevant local and National agencies to develop an appropriate scale bike share scheme for Kilkenny City. This motion recognises that small scale bike schemes have worked successfully in municipalities under 30,000 population and can have wide environmental and health benefits as well as complimenting other ‘modal shift’ projects such as public transport in small urban centres.”
