Callan Local Area Plan - Nicolaas Louw - Senior Executive Planner

Nicolaas Louw - Senior Executive Planner informed Members of the recent appointment of SLR Consultants to work on the Callan Local Area Plan for the Council. Kilkenny County Council will be consulting with the Callan Town Team in the near future..

He introduced Amy Granville, the new planner, and announced that with the extra capacity the Council shall shortly be commencing the review of the Thomastown Local Area Plan.

All the members welcomed Amy Granville and raised the following queries re the Callan Area:

- Abandoned housing site in Lower Bridge Street
- Derelict site at old Health Centre

Nicolaas Louw and Anne Maria Walsh provided Members with an update on the above queries.

Update on Repairs to City Hall Clock - Simon Walton - Senior Engineer

Mr. Simon Walton, Senior Engineer, made a presentation to members on the repairs to the City Hall Clock Tower. Photos were show to demonstrate the works to date and details on timelines and the remaining work were outlined. The lighting of the clock and other historical sights in the City including St Mary's Cathedral were discussed.

Mr Simon Walton explained about the opening time on Talbot Tower and agreed that access to St Mary's in Callan would be investigated.

A discussion took place in relation to the motion. Mr. Nicolaas Louw explained in detail about the County Development Plan and Local Area Plans in current legislation. Members wanted it noted that the former Borough Council Urban Area was too important to the County to be just another Local Area Plan. Mr. Tim Butler explained that under legislation the process of drawing up the new development plan must be commenced now. The City plan would be a chapter within the plan and it would have a stronger bearing than an ordinary Local Area Plan. Members re-iterated the importance of having a specific City Plan.

confirmed that the Breagagh Valley Park would be development at the same time as the road.
