ROADS

MAJOR PROJECTS

(Included in NDP- Funded by TII)

N24 Waterford to Cahir Scheme

The Design Team is working on corridor options. The Project Liaison Officer (PLO) is continuing to work with landowners to agree access to facilitate the completion of the preliminary ground investigation works. Although investigation works commenced in November 2022, the works were suspended in December 2022 due to saturated ground conditions as a result of consistently poor weather.

The works recommenced in March 2023 and are due to be completed in June 2023. The findings of these investigations will input into The Preferred Transport Solution.

This was scheduled to be put on public display at the end of Q2 2023, however this is now scheduled to take place in Q4 of 2023.

MINOR PROJECTS

(Not included in NDP-Funded by TII)

N24 Tower Road (Safety Scheme)

The tender in respect of construction of the scheme was awarded to Wills Bros Ltd, Co. Mayo on the 1st December 2022. Construction remains marginally ahead of schedule. Substantial completion is expected by the end of 2023.

N77 Ballyragget to Ballynaslee

The preparation of contract documents is ongoing and it is expected that the tender will be issued in early Q3 2023. The overall outturn cost for the project is expected to be in excess of €10m.

N24 Carrick Road:

Simultaneous applications to An Bord Pleanála for 177AE Planning approval and Compulsory Purchase Order Approval was made on the 25th November 2022. The public consultation period for both ran until the 20th January 2023.

There were 5 objections to the Compulsory Purchase Order Approval application. There were also 5 objections to the 177ae planning application.

It is a matter for An Bord Pleanála to determine if there is a requirement for oral hearings for both applications. Kilkenny County Council is in discussion with the valuers representing objectors to the CPO to discuss their concerns.

Pavement Schemes

The N77 Georges Tree to Dunmore West (*Phase 1 Ardloo Junction North*) Pavement Improvement Works has been awarded to Priority Construction Ltd. The civil works are complete and pavement works are to commence shortly.

The preparation of tender documents is ongoing in respect of the N77 Suttonsrath Pavement Scheme. This will link directly with the N77 Georges Tree to Dunmore West (*Phase 1 Ardloo Junction North*) Pavement Improvement referred to above.

It is intended to have this project out to tender by June 2023 with a view to construction commencing during Q3 2023.

The design work is ongoing in respect of the N76 Callan By Pass Pavement Scheme is on-going. It remain targeted to have these awarded for construction in 2023. The Callan By Pass scheme in particular is complex given its semi urban location.

National Road Bridge Works

The N10 Ossory Bridge Rehabilitation Scheme has been awarded to Cunnor Construction Ltd. The works have started with an expected 22-week construction period. The overall outturn cost for the project is expected to be just under €2m.

Kildare County Council are project managing N10 Ossory Bridge Rehabilitation Scheme under a Section 85 Agreement on behalf of Kilkenny County Council.

The works will entail significant works to the approaches and parapets of the bridge structure and will provide a significant enhancement of the existing substandard shared surface facilities across the structure.

ENVIRONMENT

CLIMATE ACTION

Public Consultation on Climate Action Plan

The public was consulted during the month of May, on what they would like to see addressed in the new Kilkenny County Council Climate Action Plan currently being prepared by the Climate Action Office. This phase of consultation included PR, talks and information at events including the Kilkenny Bike Fest, the annual Tidy Towns Network Forum, Earth Day, the Kilkenny PPN Plenary, the Kilkenny County Council Plenary meeting and the Home Energy Information Event. Submissions were invited on consult.kilkenny.ie, and by email.

A review of climate-related submissions received on recently prepared plans was also undertaken, including the County Development Plan, the Local Economic and Community Plan and the National Climate Conversations Report and workshops. A report summarising the submissions is being prepared and the findings will inform the actions in the Climate Action Plan. The public will have a second opportunity to make submissions on the draft plan in the Autumn.

Home Energy & Climate Information Event, Loughboy

The Home Energy Information Workshop organised by South East Energy Agency and Kilkenny County Council Library Service, Loughboy was a great success and had a wonderful turn out with members of the public keen to learn about energy savings at home.

Kilkenny County Council's Community Climate Action Officer Breda Maher was a guest speaker on the day and advised on the Community Climate Action Fund due to be launched soon.

Climate Action at the Tidy Towns Forum, Castlecomer

The annual Kilkenny Tidy Towns Forum organised by Kilkenny County Council and Castlecomer Tidy Towns took place on the 24th May in Avalon Hotel, Castlecomer with presentations from the Climate Action Team on the Climate Action Plan and the Community Climate Action Fund. The importance of Tidy Towns and their work in the community was highlighted as playing a key role in tackling climate change at a local level. There was a terrific attendance with 16 Kilkenny Tidy Towns groups represented.



Climate Art Competition, City Hall

Hosted by the Mayor of Kilkenny, Cllr. David Fitzgerald, the Carbon Neutral Art Competition brought teachers, family and friends together to produce artwork and models of some of the City's best-known buildings, such as, Kilkenny Castle, City Hall and Nolan Park. Students made use of recycled materials. Alexander Grey took first prize for his depiction of City Hall.



The Mayor paid tribute to all the wonderful art projects. Speaking at the event, Acting Director of Services Denis Malone highlighted the importance of recycling and reusing materials. Kilkenny County Council supplied small goody bags to the children for their efforts in taking part.

Climate Hero Challenge

The national Climate Hero Challenge was a great success in County Kilkenny with 19 individual teams and 129 people (out of a total 517 participants in Ireland) taking part. Together in the 2 weeks Kilkenny saved over 8,500kg in CO₂ emissions – the same amount as 856 trees absorb in one year! This challenge showed how small changes to our everyday lifestyles do make a significant difference.

Kilkenny County Council led by example with 2 teams - Kilkenny Fire and Rescue Service placing a fantastic 4th and Kilkenny County Council placing 11th overall in the County.

Bring Banks Usage

The Council provides and manages 46 Bring Centres across the City and County. A total of 874 tonnes of recyclables were collected from our Bring Centres so far in 2023. This represents a 18% increase on the same period last year. Loughboy Shopping Centre (18 tonnes collected), Lidl Johnswell Road (12 tonnes collected) and Aldi Kilkenny City (11 tonnes collected) are the busiest locations in the City and Mooncoin (12 tonnes collected) is the busiest outside of the City. Environment staff are continuing to work very closely with our service providers to ensure the collection service is in keeping with demand, especially around long weekends and holiday periods.

Environment Complaints

All Environment complaints received are logged on the CRM (*Customer Relations Management*) System. The number of complaints being received and logged by Environment staff for investigation for the first five months of 2023 was 402 compared with 419 for the same period last year (*i.e. down circa 4% for the year to date*). The nature of these complaints ranged from littering, illegal dumping, illegal signage and abandoned cars. The vast majority continue to be related to littering and illegal dumping (69%).

Community Monuments Fund

6 projects have been approved for community monument funding by the Department for 2023.

Funding for Capital Projects (Stream 1) are listed below

- Butler Gallery complex/garden medieval wall
- Grangefertagh historic church and graveyard
- Thomple historic church and graveyard

Requests for tenders will be issued in the next few weeks to contractors for prices in order to carry out the conservation works on all three projects.

Funding for Conservation Reports (Stream 2) are listed below

- Tubbrid Medieval Church
- Rathpatrick Medieval Church

Our consultant is now in the process of getting specialist consultants on site to carry out various assessments with regards to ecology & archaeology in order to submit a conservation report which will form part of a capital project community monument application (Stream 1) for next year

PARKS & SPECIAL PROJECTS

Woodstock Gardens

In recent weeks staff have undertaken significant replanting of the herbaceous borders of the Walled Garden. Whilst the planting is still quite young it will develop over the summer period. Owing to this fact; signage has been put in place to inform visitors of the current transition of this feature within the gardens. The planting palette has naturally drawn upon the varieties common to the Victorian era, but also to include pollinator friendly plants, which will provide a valuable food source for our important pollinators.

Additionally, our food and beverage offering is now in operation for the tourist season, currently open at weekends extending to the Tea Room Conservatory, coffee truck and ice cream hut. As the summer progresses the opening hours shall be extended to reflect the increase of visitors.



Woodstock - Accessible Play Equipment

In 2022, we were successful in seeking funding via the Disability Participation and Awareness Fund. This funding, along with funding secured under the ORIS, allowed for the provision of a new wheelchair See-saw and accessible Play Tower to complement our existing playground. The installation was completed in May and has now undergone a ROSPA safety inspection, which allowed for the new components to be opened to the public for the June bank holiday weekend.

Our new fully electric and wheelchair accessible buggy was delivered during the month. This new addition to the gardens builds on our objective to make the gardens more accessible for all. The vehicle was purchased from grant funding secured under the 2022 Disability Participation and Awareness Fund. The vehicle can accommodate wheelchair users without the user having to exit their wheelchairs as well as accommodating 9 additional passengers. Accessibility ramps are currently being constructed at the Toilet Block and Tea Room and driving training is to be rolled out shortly in anticipation that a scheduled service will be operational later in the summer.



Woodstock Committee.

The inaugural meeting of the newly established Woodstock Committee was held on Friday the 12th May. The Terms of Reference for the group were discussed, which focus on inputs and recommendations on the offering and promotion of Woodstock Gardens so as to maximise the natural, built and cultural heritage of same as a tourist destination. The Committee were given an overview of the annual budget and details of improvement works completed over the past five years from funding secured from various Capital funding streams. It was noted this investment amounted to just over €1,000,000 over the five year period. After the meeting the Committee were offered a tour of the Gardens to see some of the recently completed enhancement works.

Parks & Playgrounds

With the approach of summer undoubtedly sees the increased activity within our playgrounds. Staff continue to play a key role to ensure they are maintained to a high standard and any defects identified and remedied in a timely manner. In recent weeks repairs have been carried out in Rosehill and Newpark to include repairs to the safety surface around particular play items. This safety surface is a highly elastic playground surface which helps in preventing accidents and protects against injuries.

Many of our playgrounds comprise of timber-based products which are primarily robinia timber play items. Using timber incorporates the natural surrounding environment, however, it does require maintenance largely in the form of repainting with timber preservative. Staff have also overseen repainting in both Windgap and Bennettsbride as shown below, which shall further ensures their longevity.



Freshford Playground & Amenity Area

In front of a big crowd, the Cathaoirleach of Kilkenny County Council, Cllr. Pat Fitzpatrick officially opened the much anticipated new playground in Freshford Village. The completed project, located beside St. Lachtain's GAA Club and National School sees an investment of over €240,000 into Freshford village, made up of a combination of funding streams, including Town & Village Renewal from the Department of Rural & Community Development, the Council's Community & Cultural Facilities Capital Scheme, the Council's own funds and funds collected locally by the Freshford Playground Committee.





The new Playground extends to just under one acre and includes a zip-wire, swings, slides, play tower, basket swing and woodland play equipment along with a new access road and carparking area to service the amenity.

The site also caters for a new wildflower meadow and additional tree planting, all of which will help to combat the decline of our pollinators.

Outdoor Recreation Infrastructure Scheme

The Minister for Rural and Community Development, Heather Humphreys TD, recently launched the 2023 Outdoor Recreation Infrastructure Scheme. An indicative budget of €16 million is available for successful projects nationally under the Scheme. Funding will be provided under four different categories of projects (Measures) based on the size of the investment requirement, similar to recent years. - 7 Measure 1, max value €30k per application;
- 3 Measure 2, max value €200k per application;
- 1 Measure 3, max value €500k;
- 2 Project Development, max value €50K.

Under the scheme applicants are required to provide 10% match funding of the allocated grant.

The closing date for applications is as follows:-

Project Development – 28th July, Measure 1 - 5th September, Measures 2 & 3 - 27th October 2023.

Masterplans:

Abbey Quarter

The Council has, following considerable fieldwork and consultation prepared a draft Masterplan for an extended Abbey Quarter area (to include Vicar Street & Greensbridge Street) along with a review of policy and the Urban Design Code (2018).

The Draft Masterplan will be on public display from Friday 2nd June to Friday, 30th June (*both dates inclusive*) and may be inspected at the following locations:

Following public consultation the Chief Executive's report will be brought back to the Council for consideration.

St. Canice's Campus

A final meeting took place with the HSE project working group on the draft spatial framework. This draft framework is still under consideration by the HSE and once approved will go to the Council's Management Team before being brought to the Municipal District members. It will then be placed on public display for public consultation. It is anticipated that consideration of the Plan by the HSE will be completed over the coming weeks, which will allow public consultation to proceed.

Loughmacask

The material amendments to the Loughmacask Masterplan and Environmental screenings reports were on public display from Friday 21st April 2023 to Friday May 26th 2023. A drop in public information session was held in St. Canice's Neighbourhood Hall on Monday 8th May 2023 from 7pm to 9pm. A total of 3 submissions were received and the plan will now go before the Council for final consideration and adoption at the June Council Meeting.

Urlingford

A first draft of the Urlingford Town Centre Masterplan has now been received from the appointed consultants and has been reviewed and returned to the consultants for amendments. Once reviewed, the proposal to place this plan on public display will be before the Municipal District members at their June Meeting. An update on the plan proposals will be provided at the July Municipal District meeting. A public workshop on this draft plan will also take place once the draft plan is placed on public display.

Ballyragget/Paulstown/Kilmacow

Work has commenced on the preparation of Masterplans for the settlements of Ballyragget, Paulstown and Kilmacow. Three public meetings, one for each town, took place 18th, 19th and 20th of January 2023. With due consideration of inputs from these meetings the consultants are currently drafting the three Masterplans, which are expected in June 2023. The draft plans will be presented to the respective Municipal Districts prior to them going on public display.

Taking in Charge

Rioch Court has been taken in charge by Kilkenny County Council.

Initiation to have the following estates taken in charge were recently advertised:

- Lakeside Housing Estate and Walkway/Cycleway: 2 submissions received
- Ogenty Housing Estate, Gowran advertised in Kilkenny People: 2 submissions received. The above submissions may result in delays to the taking in charge process.
- Abbeygate, Ferrybank – works complete and ready for final sign off.
- Internal Road to Retail Park – Developer to appoint contractor for required works.
- An Choill Rua, Paulstown – small number of items remain outstanding - to be completed by the developer.
- College Park, Callan Road – contact made with Developer. Schedule of works to be collated and agreed.
- Friarshill, Graiguenamanagh - schedule of works and costs agreed with the Area Office. Works will proceed later in the year.
- Rathullard – surface dressing completed on Phase 1, ramps to be installed by the Area Office. The Developer has applied to have the next phase of this development taken in charge

E-Planning

Applications through e-planning continue to increase.

Users must register on the e-planning portal at: <https://planning.localgov.ie/en/local-government-ireland-planning-system>, where after they can then make a planning application, submit documentation online with the application and submit further information later if required. The status of applications can be viewed quickly and easily. Paper applications are still accepted and

the same timelines apply to both an online application and a paper application.

Active Land Management

The Draft Maps of land in scope for the Residential Zoned Land Tax were published on the 1st November, 2022. A total of 25 submissions were made to the process. Determinations were made on each of these submissions, and landowners were notified of the determinations. A total of 12 landowners appealed their determinations to An Bord Pleanála. Along with 14 other Local Authorities, Kilkenny is not publishing a Supplemental Map, as there are no additions to the maps of land in scope for the tax. A Final Map of lands in scope for the tax will be published by 1st December 2023.

There are 31 sites on the Derelict Sites Register. One site in Graiguenamanagh was added to the Register and two other sites were subject to notices of intent to be added to the Register.

There are 24 Vacant Sites on the Vacant Sites Register and the number of cancelled entries due to site activation or improvement is 23. A payment of €28,000 was received for a vacant site in Ferrybank in April. The Vacant site levy will be replaced by the Residential Zoned Land Tax in 2024, but any outstanding levies will remain due to the Council.

Conservation

The Conservation Office manages all protected structures in Kilkenny County and City. These structures are recognised for the following special interest: Architectural, Historical, Archaeological, Artistic, Cultural, Scientific, Technical, Social.

Conservation grants 2023: Engagement with successful applicants for the Built Heritage Investment Scheme and the Historic Structures Fund conservation grant schemes are underway. Discussion will centre on agreeing appropriate specifications and methodologies for repair works.

Heritage Stewardship Programme 2023: Three consultants have been invited to tender for the delivery of laser scans, photogrammetry and building interpretations for two 16th century buildings on Parliament Street. This process is ongoing.

Sessions House Official Opening

On the 17th May, Minister Heather Humphreys officially opened the Sessions House redevelopment project. This project, funded under the Rural Regeneration and Development Fund, together with a contribution from the Leader Programme through Kilkenny Leader Partnership and match funding from Kilkenny County Council has delivered a significant investment in the creative sector and in Thomastown.

This development represents a commitment to supporting and promoting the progression of new creative talent to employment in the creative sector. Sessions House will accommodate the Jewellery & Goldsmithing on-site campus, previously located at Castle yard Kilkenny. These courses have attained Level 8 accreditation from Atlantic Technical University (ATU) in partnership with DCCI representing a significant move forward with the provision of Third Level Education in Kilkenny.



Community and Cultural Facilities Capital Scheme 2023

The closing date for the Community and Cultural Facilities Scheme was Friday the 19th of May. Kilkenny County Council have received 17 applications for funding from community groups across the County. The evaluation process will take place and results will be presented to the Elected Members at the July Council Meeting for approval.

Africa Day

The Africa Day Celebrations took place on Saturday 27th May in the Home Rule Club, Johns Quay. The event was well attended with 250 people visiting throughout the day. This was a multicultural event showcasing cultural music, dance, food and craft from across the continent.




Biodiversity

Bernadette Moloney, the Council's Biodiversity Officer is now based in the Community Section. In May, she spoke at the Tidy Towns Forum and PPN plenary outlining the role and the interconnectivity the post will have with communities.

Local Biodiversity Action Fund

The National Parks & Wildlife Service (NPWS) of the Department of Housing, Local Government and Heritage has approved grant funding of €99,252 to Kilkenny County Council under the Local Biodiversity Action Fund. Projects include biodiversity training, the continuation treatment programme to eliminate invasive alien plant species which threaten the biodiversity of Silaire Wood, and Woodstock Gardens & Estate, projects with BirdWatch Ireland to further safeguard the Swift and Barn Owl population in Kilkenny and ecological assessments to determine the condition of hedgerows throughout the County. The Biodiversity Officer will oversee these projects as part of her brief.

The first public event relating to the successful Local Biodiversity Action Fund is a Swift Walk that takes place in Kilkenny City on the 22nd of June with BirdWatch Ireland. Everyone is welcome to attend, to view swifts in flight, to learn more about these summer visitors to Kilkenny and hear what we can do to safeguard their population as it's a species in decline and they need our help.

Heritage Council launches National Heritage Week

Irish Walled Towns Network funding awarded

Kilkenny County Council has been awarded funding for interpretation of the City Walls of Kilkenny under the Heritage Council ITWN grant scheme. The aim of the project is to design and install information plaques on 5 key sections of the Kilkenny City walls. This is Phase 1 of a larger project to develop a trail of Kilkenny City walls. Phase 2 will involve installation of further plaques and development of a trail route and information.

Holy Wells and Mass Paths of County Kilkenny

Kilkenny County Council has been awarded funding to undertake a countywide survey of holy wells (Phase 1) and to carry out a pilot study to develop a methodology for surveying mass paths in County Kilkenny.

The Heritage Office seeks your assistance in collecting information about these sites around the County.

If you are aware of a holy well or mass path local to you, please contact heritage@kilkennycoco.ie. Holy wells and mass paths are sacred places in the local landscape and are held dear by local people. They are of cultural, archaeological, ecological, folklore, spiritual, religious and geological significance.

This project will collect data and raise awareness about the holy wells and mass paths of Kilkenny and the traditions and practices associated with these often lesser-known aspects of our cultural heritage with a view to helping to ensure their care and protection.

ARTS

Visual Artists Needs Analysis

Kilkenny Arts Office has joined up with Visual Artists Ireland to conduct a County Kilkenny Visual Arts Needs Analysis. This consists of an in-depth online survey that artists in Kilkenny are asked to complete.

Visual Artists Ireland will then use this to map the strengths, weaknesses, gaps, cultural infrastructure and opportunities for visual artists in Kilkenny. This is followed by a visual artists café that will explore current visual arts practice in Kilkenny. A final report will be given to the Arts Office.

Your Voice Matters Collaboration Skills For Success Workshop

As part of the Arts Office Your Voice Matters programme a one-day workshop took place at Butler House on the 9th May. This full day, interactive, practical, and fun workshop gave participants across all artforms an experience of working together collaboratively and the knowledge, tools and resources to become more effective collaborators, whatever project they're working on.

A total of 20 artists across artforms attended and topics covered included:

- The Conditions required for True Collaboration
- Purpose – What Impact do we want our Work to have?
- Importance of Contracting & Building Trust

It was a relaxed, informative and interactive workshop that set the foundation for their work over the year.

Poetry Broadsheet

Broadsheet editor Afric Mc Glinchey selected a total of 12 poems for publication in this year's poetry Broadsheet.

Poets included: Mike Watts, Anne Mac Darby Beck, Emily Murtagh, Paddy Doyle, Alice Bennett, Noel Howley, Eamonn Donovan, Nuala Roche, Mia King, Breda Joyce, Canice Kenealy and Darren Caffrey.

The poems are now with the illustrator Louise Naughton who will design and illustrate the Broadsheet.

Emerging Curator In Residence Programme

The emerging curator Shannon Carrol is in the process of setting up her first exhibition of the year titled *Horizon | Ag Bun na Spéire*, an immersive multimedia installation by visual artist Catherine McDonald which presents an imaginary landscape.

Blending fact with fiction, the exhibition speculates upon human ideologies of life on alternate planets.



Energy Efficiency Grant Launched

The Energy Efficiency Grant supports the investment in technologies and equipment identified in a Green for Micro Report, GreenStart Report or a SEAI Energy Audit with 50% of eligible costs up to a maximum grant of €5,000.

The aim of the scheme is to reduce the impact of enterprises on the environment thereby increasing the agility and resilience of these businesses.

Eligible Costs

- Meters (*electricity, gas, diesel, oil, water, steam & loggers*) and installation costs
- Smart energy controls e.g., heating, cooling, lighting, automatic on/off systems, parasitic load controls
- Upgrade lighting to LED (*only as part of a package of eligible cost measures*)
- Replacement/upgrade with more energy efficient system, e.g. Heat Pumps (*including air, water, and ground source*) for manufacturing heating processes

Homeless Prevention Measures

The government have put in place a number of measures to prevent homelessness arising from the reactivation of notices of termination of tenancies in May 2023.

We are currently providing advice and directing Tenants to the appropriate services required to prevent homelessness. Where a household is in receipt of a valid notice to quit and requires assistance in establishing what options are available to them to avoid potential homelessness they are advised to contact the Housing Office at its dedicated email address, NTQEnquiries@kilkennycoco.ie. Further details are available on www.kilkennycoco.ie. Any tenants who may have received a notice of termination or a landlord who has issued a notice of termination to their tenants and who may wish to in the coming months should direct any queries to the dedicated email provided and all queries will be responded to in a timely manner.

Vacant Homes

The Vacant Properties Refurbishment Grant, Croí Cónaithe is among the suite of measures under the pathway to addressing vacancy and efficient use of existing stock in Housing for All. The grant is aimed at bringing vacant and derelict properties back into residential use. The scheme was originally for people who were refurbishing vacant properties for use as their principal private residence. The government has recently announced that as of 1st May 2023, there will be a number of changes to this scheme including that the scheme will be expanded to property owners who wish to refurbish their vacant property for rental purposes. The detail and guidance regarding the modified scheme has not yet been issued by the Department of Housing, Local Government and Heritage. There has been a substantial increase in the number of calls to the Housing Department regarding this scheme and a register of all inquiries to the Council is kept for follow up when details and application forms are provided.

Rent-a-Room Scheme

Announcements have been made in the media that the Rent -a- Room scheme will be extended to local authority social housing tenancies. This action is included in Housing For All and seeks to secure additional accommodation due to growing pressures in the private rental sector.

The Rent -a- Room Scheme currently allows a householder to earn up to €14,000 per year tax-free by renting out a room (or rooms) in their home to “private tenants”.

Recent announcements indicate the governments intention to extend this scheme to local authority tenants but no details are yet in place. We are not in a position to process any applications to proceed under this scheme at present. There are many concerns around the implementation of this scheme which need to be addressed before it can proceed.

The Tenancy Management Team deal with allocations, maintenance and anti-social behaviour complaints in relation to our tenants.

The Tenancy Management section has commenced legal proceedings in respect of four tenancies where repossession orders have been sought. Where anti-social behaviour is ongoing, tenancy notifications and warning notices continue to be served and monitored. Where tenants engage in anti-social behaviour relating to offences under the Misuse of Drugs Act or violence and intimidation resulting in criminal charges, the local authority will take enforcement action to terminate the tenancy and alternative social housing supports will not be provided.

Voids

At the end of March 2023 [end Q1] there were 44 vacant units of local authority accommodation awaiting refurbishment or remediation works.

Under the 2023 Voids Maintenance Programme Kilkenny County Council have recently received Department funding in the amount of €528,000 for renovations to 48 units. Works are ongoing on this voids maintenance programme and its envisaged that a minimum of 75 units will be refurbished under this programme during 2023.

Self Help Scheme

The Self-Help Scheme is a new scheme available to Council tenants in 2023. The objective of this scheme is to assist Local Authority tenants to carry out improvement works to their home, which are deemed to be tenant responsibility. Kilkenny County Council will pay 50% of the cost of the works up to a maximum contribution of €1,250.

Housing Grants

The 2023 housing grants allocation has been received from the Department of Housing, in the amount of €1,991,076, comprised of €1,592,861 (80%) grant and €398,215 (20%) Council's contribution.

This allocation exceeds the amount included in the budget for 2023 and reflects the Departments confidence in the grants section to meet and exceed its targets for 2023. The funding approval also confirms that the local authority cannot exceed the maximum grant amounts under legislation and that these maximum amounts have not been revised.

Housing Capital

The current Kilkenny County Council Housing Delivery Pipeline is:

- In 2023 - expected delivery is 121 units (not including acquisitions or leasing). Housing for all Target (HFA) is 149 units.
- In 2024 - expected delivery is currently 237 units whereas the HFA target is 153.
- In 2025 - delivery currently stands at 114 units. This is expected to increase as more projects come on stream.

The improvements made by Department of Housing to the CALF programme, which funds AHB delivery is expected to result in additional units to the delivery programme above, as activity in this area has increased.

The Vacant Homes Data Survey is underway. This will assist in identifying suitable properties for reuse that will be acquired by agreement or CPO. 393 properties (which were identified in Geodirectory as being vacant) have been surveyed to date with 153 being confirmed as vacant.

The Vacant Homes refurbishment grant continues to receive applications from people seeking funds to bring vacant properties back into use as homes.

UKRAINIAN RESPONSE UNIT

Offer A Home

The 'Offer a Home' programme is asking property owners who have a house, apartment or holiday home that is not currently being used to offer it to people and families from Ukraine who need a safe place to stay. The 'Offer a Home' programme is being managed by Local Authorities on behalf of Government. Kilkenny County Council 'Ukrainian Crisis Unit' is managing this programme at local level & liaising directly with property owners. A Government tax-free recognition payment of €800 per month is available to property owners offering accommodation to those fleeing the Ukraine. Community Forum Monthly Focus



Kilkenny Volunteer Centre is part of the network of 29 Volunteer Centres across Ireland who are affiliated to Volunteer Ireland, the national development agency for volunteering in Ireland. The Volunteer Centre has become a great place for Ukrainians to integrate into the local community.

The following are projects that the Volunteer Centre have co-ordinated and linked with our Ukrainian Community into volunteering in Kilkenny.

One Million Stars

This project is in support of the Amber Women's Refuge and a large number of Ukrainian volunteers have woven stars for the project.

Army Barracks Sorting Centre

This was back in the early days of the Ukraine crisis when we facilitated local volunteers to help sort donated clothes from public appeals.



Sunflower Shop

Set up at the start of the crisis, the Sunflower Shop provided an Information Centre and location to pick up items for free and was operational in Meubles on John Street until October 2022 and Ukrainian volunteers were very involved in this project. This facility has now moved to the temporary rest centre at St. John of God Convent.



Kilkenny Welcomes Community Recognition Funding

A total sum of €948,063 was announced in May for 19 projects around the County under the first Community Recognition Fund, which aims to support the development of community infrastructure and facilities in recognition of the contribution being made by communities across the country in welcoming and hosting significant numbers of arrivals from Ukraine and other countries.

The funding is specifically targeted at projects that are located in communities, towns and villages that are hosting the Beneficiaries of Temporary Protection and/or International Protection Applicants (*'new arrivals'*) including towns identified for the rapid build homes programme.

The Fund aims to support the development of facilities that will be used in the future by all members of the community. It is separate in its objectives and scope to any other public funding streams which aim to support the development of public service needs arising from the significant number of arrivals from Ukraine.

€50 million was made available under the Fund and this has been allocated between each local authority based on the number of new arrivals located there. €30 million of the Fund will be available in 2023 and €20 million in 2024. A minimum spend of 60% must be incurred by the local authorities in 2023 with the remaining 40% in 2024.

The applications submitted by Kilkenny were based on the number of Ukrainian arrivals to County Kilkenny as per CSO statistics in December 2022. There are currently over 1,550 Ukrainians now resident in Kilkenny.

Cathaoirleach of Kilkenny County Council, Cllr Pat Fitzpatrick has welcomed the funding stating that *"this will have a positive impact on communities throughout Kilkenny and thanked those communities for welcoming Ukrainians into their towns and villages"*.

FIRE SERVICES

Capital Projects

Contracts for the purchase of a new site for a fire station for Kilkenny City have been signed subject to planning. The site for the new station is a 3-acre site at the Kilkenny Business and Retail Park, Waterford Road, Kilkenny. Invitation to tender for the provision of design consultancy services for the new fire station will be submitted for tender in the coming days.

The construction of the new fire station for Urlingford is complete and is due to be handed over in June 2023.



Fire Safety Certificates

61 applications for fire safety certificates were received to date.

44 applications were received for the same period last year.

Fire Services Acts 1981 and 2003

Fire Prevention staff made targeted inspections of premises both to provide advice and to enforce legislation.

5 Licence Applications were processed under Section 24 of the Fire Services Acts 1981 and 2003.

18 Fire safety inspections of premises have taken place so far this year.

Community Fire Safety

Fire service personnel call to houses by appointment and give fire safety advice to the occupants. A HFSV is usually carried out by two uniformed operational fire service personnel. The primary aim of these HFSVs is to reduce the numbers of fires, deaths and injuries in the home by firstly preventing fires occurring and to ensure that when fires do occur, the occupiers are given early warning and they know how to react quickly and safely.

A number of school visits to our fire stations was facilitated by our firefighters. Topics ranged from – Call the emergency services 112 – Testing your smoke alarm – Road safety awareness were covered in a fun and engaging way.

Firefighters have been very busy in visiting their local primary schools to deliver the very successful primary schools programme. This programme has been delivered since 2006. as part of annual on-going community fire safety programme – the fire officers delivered the Primary School Programme (PSP) which covers: Fire safety in the home, the importance of smoke alarms, Test it Tuesday, what are the hazards and risks of accidental fires we have in our homes, how these can be prevented, how to call your local fire brigade 112, What to do if you do have a fire in your home

Fire Brigade Operations

The Brigades have attended 287 incidents to date in 2023. These incidents included a number of road traffic collisions, public road hazards, domestic fires, automatic fire alarm activations chimney fires and an increasing number of ambulance assists in recent weeks.

National industrial action SIPTU Retained Fire Fighters.

SIPTU have advised that their members in the Retained Fire Service will commence industrial action on the 6th June this will be followed by rolling strikes on the 13th June and all out strikes on the 20th June.

SIPTU have confirmed that throughout the strike action it will comply with the provisions of the Code of Practice on emergency disputes reflecting the professionalism and dedication of its retained fire service personnel to ensure that fire services are provided even in a strike situation and have confirmed that it will respond to all emergency calls involving life-threatening situations.

Fire Service Training



Mobile Library Update

May has been another very busy month on our Mobile Library. Overall we served 77 locations, had 1,113 visits and issued 4,179 books.

Staff are currently amending the timetable to facilitate visits to schools in Ballyfacey, Mooncoin and other locations. For the first time, rural schools served by the mobile library are taking part in the annual Summer Stars Reading Adventure.

Over the past few months a number of book clubs have been established countywide. Meetings take place monthly at The Loop Café, Freshford, The Lakeside Tearooms, Windgap and The Rod Iron Café, Mullinavat. All are at maximum capacity. Book sets are provided by the library service and the meetings are facilitated by mobile library staff. This new outreach initiative has created a vibrancy around our villages and has resulted in increased awareness and usage of our service.

Visits took place to a number of nursing homes in celebration of World Poetry Day. The nursing homes staff are most appreciative of all the library service does for them. They feel well supported and are impressed with our creativity.



Finance Update

The bank overdraft facility was not utilised during the five-month period to the end of May 2023. The draft unaudited financial statements for 2022 were finalised and presented to Council at the March meeting. The Local Government Auditor commenced the audit for 2022 on the 22nd of May 2023. The annual rate demands for 2023 were sent to all rate payers in February.

Rates Revaluation

Further to Revaluation 2017, 197 customers with a total rate demand value of €4.5m appealed their new valuation to the Valuation Tribunal. To date 193 appeals have been completed. The following is a breakdown of the appeal outcomes to date:-

Decrease in Revaluation on Appeal	149 cases
Appeal Withdrawn	34 cases
Increase in Revaluation on Appeal	1 case
No change to Revaluation on Appeal	10 cases
Appeals outstanding	3 cases

The total annual Income lost to date stands at €853k.

Commercial Rates Vacancy

The commercial rates vacancy remains at 90% for 2023. A 90% vacancy strike off will be applied to eligible commercial rate accounts for 2023, where the customer formally applies, provides proof of vacancy and clears any outstanding rate arrears, where applicable.

Working Capital Facility for Community projects co-funded with Kilkenny Leader Partnership

There are a number of community projects jointly funded by Kilkenny County Council (KCC) and Kilkenny Leader Partnership (KLP). These projects require a working capital facility from KCC until the KLP grants are paid out. Elected Members have approved a revolving working capital facility for community groups subject to detailed terms and conditions. A maximum of €500k has been provided for all projects.
