Site Location & Description:

Rioch Court is a residential mixed development of housing and apartments with a total of 54 Units, located in Kilkenny. The site is served by mains water and sewerage, and is accessed via a single entrance from St Rioch's St.

Planning History:

P98/061 & PL.62.110479 - To demolish house nos. 10,11,12,13 and 14 St Rioch's Terrace and to construct 19 houses and 8 apartments with access from St Rioch's Terrace.

P00/104 - To construct 9 apartments on lands at St Rioch's Court

P00/105 – To amend planning permission number P98/061 St Rioch's Street by changing block \$1) from 5 houses to 9 apartments on lands at St Rioch's Street.

00/111 - To construct 4 apartments on lands at St Rioch's Court

04/020 - Retention of development to retain amendments made to the second floor of block E, changing it from 2 no two bed apartments 33 and 34 to one bed apartments 33,34,35,36

and ancillary change to the site of adding 6 number car park spaces. This is amendment to planning ref 00/104

TIC Request:

There was a formal application to have Rioch Court taken in charge in 2013. Subsequent to this, the planning authority claimed the bond. The full value of the bond has been paid by the bondholder, which will allow all remaining works to be procured and arranged by the planning authority.

Please also note, final taking in charge is not dependent on the completion of the remaining works. If needs be, the completion of the works can continue after taking in charge. This principle applies to works where the planning authority is in receipt of the bond money and is arranging the works.

Recommendation:

Having regard to the planning authority being in receipt of the bond money, and the planned completion of all works identified by the various internal service areas to bring the estate to taking in charge standard; I recommend that Kilkenny County Council initiate proceedings for the taking in charge of Rioch Court, Kilkenny, as outlined on the attached
